**PART 55, AIR POLLUTION CONTROL, NATURAL RESOURCES AND ENVIRONMENTAL PROTECTION ACT, 1994 PA 451, AS AMENDED.** The Air Quality Division will be holding a public hearing on May 3, 2012 at 1:00 p.m. on proposed revisions to the Air Pollution Control Rules (ORR 2010-035 EQ). The proposed revisions to Part 2, Air Use Approval, R 336.1201 to R 336.1299, will provide the Department with the legal authority to write and issue permits for facilities that become subject to federal Title V requirements by virtue of their greenhouse gas emissions and will incorporate emissions thresholds for the pollutant PM 2.5. **COLLABORATIVE STAKEHOLDER INITIATIVE (CSI) – REINVENTION OF STATE’S CLEANUP AND REDEVELOPMENT PROGRAMS.** Recently the Michigan Department of Environmental Quality (DEQ) embarked on a Collaborative Stakeholder Initiative (CSI) to reinvent the state’s cleanup and redevelopment programs. The DEQ selected the following seven areas on which to focus recommendations for improvement.

- Brownfield Redevelopment
- Groundwater Surface Water Interface
- Cleanup Criteria
- Part 201 Rules
- Due Care Obligations
- Vapor Intrusion
- Free Product/Source RemovalCsat

The DEQ partnered with stakeholders and Michigan State University (MSU), through its’ Cooperative Extension (MSUE) to design and implement this process. **WATER QUALITY MONITORING GRANT APPLICATION PACKAGE (GAP).** The Department of Environmental Quality’s (DEQ) Water Resources Division announces the availability of a GAP for water quality monitoring projects using fiscal year 2012 Clean Michigan Initiative-Clean Water Fund monies.
