PROPOSED STORM WATER DESIGNATION FOR YARD CLIPPINGS COMPOSTING FACILITIES. The Water Resources Division (WRD) is proposing that storm water discharges from municipal and industrial yard clippings composting facilities be designated to be significant contributors of pollutants to waters of the state pursuant to Rule 2161(1)(f) of the Part 21 rules, Wastewater Discharge Permits, promulgated under Part 31, Water Resources Protection, of the Natural Resources and Environmental Protection Act, 1994 PA, as amended. Comments on this proposed designation will be accepted thru September 8, 2015, and may be submitted to Ryan Grant, at grantr3@michigan.gov or DEQ, Grand Rapids District Office, 350 Ottawa Avenue, NW, Unit 10, Grand Rapids, Michigan 49503-2316. The WRD understands the beneficial use of compost generated from yard clippings and the potential growth within the industry. Appropriate management of compost wastewater and storm water is very import at yard clippings composting facilities. A 2013 study performed by WRD staff indicated that compost wastewater generated at yard clippings composting facilities has the potential to negatively impact waters of the state if not handled properly. Compost wastewater discharges from yard clippings composting facilities can contain significant levels of nutrients, heavy metals, oil and grease, soluble salts, Biochemical Oxygen Demand (BOD), Chemical Oxygen Demand (COD), tannins and phenols from decomposing leaves, herbicides, pesticides, fungicides and fecal coliform. Given the nature of the industrial activity at yard clippings composting facilities the WRD concluded that it is a reasonable expectation that storm water generated at the facilities will

contain many of the same pollutants identified in the compost wastewater.

What the proposed designation means to the regulated community:

Commercial and municipal yard clippings composting facilities which meet all of the following criteria would need to obtain a National Pollutant Discharge Elimination System Industrial Storm Water Permit:

(1) The facility's Standard Industrial Classification (SIC) code is listed in the federal storm water regulations and / or the facility meets the definition of a yard clippings composting facility under the [Part 115 rules](#). Most commercial yard clippings composting facilities are categorized under SIC code 2875, which is listed by the federal storm water regulations. SIC code designation is used to describe what the primary source of revenue for a facility is and / or the industrial activity that employs the most employees. It is common for facilities to have multiple SIC codes to accurately describe the full range of their industrial activities.

(2) The facility has exposure of industrial materials and / or activities to storm water. Industrial materials and / or activities associated with yard clippings composting facilities include but are not limited to: vehicles and equipment maintenance, outdoor fuel and chemical storage, dust suppression activities, exposed soil, material (raw, intermediate, final) loading and staging areas, access and haul roads, vehicle tracking of sediment, etc.

(3) Storm water from the site discharges to a surface water of the state.

This proposed designation goes beyond the standard SIC code criteria used to determine regulated industrial activity in the federal and state regulations, however given the nature of the industrial activity at yard clippings composting facilities and the potential for water quality violations it has been determined to be a reasonable expectation.
