PART 55, AIR POLLUTION CONTROL, NATURAL RESOURCES AND ENVIRONMENTAL PROTECTION ACT, 1994 PA 451, AS AMENDED. The Air Quality Division will be holding a comment period and public hearing on January 26, 2015, at 1:30 p.m. on proposed revisions to administrative rules promulgated pursuant to Part 55, of the Natural Resources and Environmental Protection Act, 1994 PA 451 (NREPA). The rules are identified as Part 9, Emission Limitations and Prohibitions – Miscellaneous. The comment period and hearing will address requirements relative to the state administrative rules and revisions to Michigan’s State Implementation Plan under the federal Clean Air Act. The purpose of these rules revisions is to adopt by reference specific federal regulations and industry testing methods, update some adoption by reference language, and move all adoptions by reference in the AQD rules to R 336.1902 to make the rules easier to use. The revisions will also remove obsolete compliance dates. Hazardous substances present in soils that either originated on or where deposited on the property include heavy metals and Polynuclear Aromatics and are addressed in the use restrictions and post-closure plans. The NFA reports document the placement and maintenance of a permanent cover/barrier over the property in order to prevent direct contact with the contaminated soils. PUBLIC HEARING ON PERMIT APPLICATION SUBMITTED BY CRAWFORD COUNTY, 200 WEST MICHIGAN AVENUE, GRAYLING, MICHIGAN 49738, MDEQ FILE NUMBER 14-20-0011-P. The Water Resources Division will hold a public hearing Wednesday, January 7, 2015, at 6:00 p.m., at the Crawford County Building in the Circuit Courtroom, 200 West Michigan Avenue, Grayling, Michigan 49738-1746. The applicant proposes construction of hydraulic renovations at the Grayling Fish Hatchery. The project consists of constructing a new channel that will bypass the existing water control structure on the East Branch of the Au Sable in order to allow native fish to pass upstream of the dam. A culvert with water control capabilities will be installed at the inlet of the bypass channel, and a footbridge will be constructed over the top of the fish bypass channel. A hydraulic barrier will be constructed at the upstream outlet from the upper raceways in order to provide separation between the river and the fish raceways. The outlet of the middle channel will be realigned, and a hydraulic control structure will be installed at the downstream end of the hatchery in order to achieve a single point of discharge from the hatchery.
