**NOTICE OF HEARING**

Take notice that an evidentiary hearing will be held before the Supervisor of Wells (Supervisor) in the city of Lansing, Michigan, on the TWENTY-FOURTH DAY OF AUGUST (AUGUST 24), 2016, BEGINNING AT 9:00 A.M., OTTAWA BUILDING, SECOND FLOOR, 611 W. OTTAWA STREET, LANSING, MICHIGAN 48933. The hearing will be conducted pursuant to Part 615, Supervisor of Wells; and Part 617, Unitization; of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (NREPA), MCL 324.61501 *et seq.*, and MCL 324.61701 *et seq.*, respectively; the administrative rules, 1996 AACs, 2001 MR 2, 2002 MR 23, 2015 MR 15, R 324.101 *et seq.*; and the Administrative Procedures Act, 1969 PA 306, as amended, MCL 24.201 *et seq.*; MSA 3.560(101) *et seq.*

The purpose of this hearing is to consider the petition of Jordan Development Company, L.L.C. (Petitioner), 1503 Garfield Road North, Traverse City, Michigan 49696, requesting an order approving:

(A) A unitized operation and the adoption of a plan for unit operations pursuant to Section 61704(4) of Part 617 for the stratigraphic equivalent of that portion of the Brown and Gray Niagaran Formations encountered in the interval from 4997 measured depth (MD) to 5024 MD in the State Springdale & Lucking 1-21 well (PN 46775) or the correlative equivalent of that interval located in the NE 1/4 of NE 1/4 of NE 1/4 of Section 21, T24N, R14W, Springdale Township, Manistee County, Michigan. The proposed unit area for the Springdale 14-15 Unit is described as:

T24N, R14W, Springdale Township, Manistee County, Michigan  
Section 10: W 1/2 of SE 1/4; SE 1/4 of SE 1/4;  
Section 14: W 1/2  
Section 15: E 1/2; E 1/2 of SW 1/4;

(B) An enhanced and/or secondary recovery or pressure maintenance operation pursuant to Section 61506(i) of Part 615 and R 324.612. The Petitioner proposes to conduct enhanced and/or secondary recovery and/or pressure maintenance operations by injecting water into the described reservoir within the Springdale 14-15 Unit described in (A);

(C) The operation of the Springdale 14-15 Unit as an exception to the applicable spacing and proration provisions of Part 615, and its administrative rules.

Take note that if you wish to participate as a party in the hearing by presenting evidence or cross-examining witnesses, you shall deliver to the Petitioner and Supervisor, not less than five days before the hearing date, an answer to the petition in the manner set forth in R 324.1204(6), or a protest as set forth in MCL 324.61704. Proof of mailing or delivering the answer or protest shall be filed with the Supervisor on or before the date of the hearing. The answer or protest shall state with specificity the interested person's position with regard to the petition. Failure to prepare and serve an answer or protest in a timely manner shall preclude you from presenting evidence or cross-examining witnesses at the hearing. If an answer or protest to the petition is not filed, the Supervisor may elect to consider the petition and enter an order without an oral hearing.
