This matter came before the Court on Defendants' Motion for a New Trial on Penalties or, in the Alternative, to Alter or Amend the Final Order and Judgment. On June 3, 2005, this Court entertained arguments from counsel for both parties.

NOW THEREFORE for the reasons set forth by the Court on the record at the June 3, 2005 hearing;

IT IS ORDERED that Defendants' Motion for a New Trial on Penalties or, in the Alternative, to Alter or Amend the Final Order and Judgment is DENIED.

IT IS FURTHER ORDERED that pursuant to MCR 2.517 and 2.612(A)(1), this Court's Final Order and Judgment of April 13, 2005 is amended to correct the citations for the \$1,418,900 in penalties for additional violations contained in Plaintiff's Motion for Summary Disposition as follows:

a.	Violation of MCL 324.21307(2)(c)(i) 5,298 days x \$100/day =	\$529,800.00
b.	Violation of MCL 324.21307(2)(c)(ii) 1,645 days x \$100/day =	\$164,500.00
c.	Violation of MCL 324.21307(2)(d) 4,223 days x \$100/day =	\$422,300.00
d.	Violation of MCL 324.21304a 3,023 days x \$100/day =	<u>\$302,300.00</u> \$1,418,900.00

IT IS FURTHER ORDERED that this Court's April 13, 2005 Final Judgment and Order with the exception of the editorial correction indicated above, is upheld and is attached to this Order for reference.
