

# Scrap Wood Recycling Locations

The owners or operators of the listed scrap wood recycling operations have notified the Department of Environmental Quality (DEQ) of their intention to operate in accordance with the Scrap Wood recycling exemption (Exemption) located at [http://www.michigan.gov/documents/deq/deq-whmd-swp-Exemption-ScrapWood\\_247543\\_7.pdf](http://www.michigan.gov/documents/deq/deq-whmd-swp-Exemption-ScrapWood_247543_7.pdf) . The Exemption was developed under R 299.4119 of Part 115, Solid Waste Management, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended. The inclusion or exclusion of a scrap wood recycling operation from this list does not reflect a determination by the DEQ on the compliance status of the scrap wood recycling operation under Part 115 or any other state or federal law, rule, or regulation. The DEQ does not recommend or endorse any scrap wood recycling operation and is providing this list to assist generators with identifying potential options for managing scrap wood they may generate. It is the responsibility of the generator to ensure drywall is delivered to a qualified scrap wood recycling facility. The DEQ maintains a Waste Data System (WDS) that contains information related to compliance activity at various types of facilities.
