Each NEP application will be evaluated by the Department of Natural Resources and Environment (DNRE). Only applications received prior to the application deadline will be evaluated for 2009 Awards. The Director of the DNRE reserves the right to make final decision on all awards. Successful award winners will be notified prior to award announcement.

The NEP applications will be separated into two categories, small and medium size business applications (businesses with fewer than 500 employees) and large business applications (businesses with greater than 500 employees). The best projects from each category will be selected to receive a NEP Award.

The NEP Awards will be announced June 2010. A NEP award certificate will be mailed to each participating group or organization listed in your NEP application. A DNRE press release will be developed for each award cycle recognizing NEP award winners and published on the DNRE Web site.
