ASUS Computer International provides free recycling service for ASUS-brand products to both Residential and Institutional users. For other-brand products, users can also use our recycling service with charges. They can use the program as described below:

To Residential (B2C) Customers:

Residential customers visit the website, fill out the information on the web and submit the form. A shipping label is mailed to the customer within 5 business days. Once customer receives the label, he/she packages the ASUS product in a box, attaches the shipping label, and drops it off at the nearest FedEx or FedEx/Kinko's location.

To Institutional (B2B) Users:

The business could visit the website and/or contact our recycler Metech Recycling at 866-479-4920 to discuss arrangements. Metech Recycling can most effectively arrange their shipping and recycling needs.

We provide basic information on how both Residential and Institutional Users can use our recycling service through our website, and at the same time provide Recycler's website which contains more detailed information, including the online submittal form and recycler's contact information.
