Premio's takeback program is free to consumer. Consumer log onto Premio recycling website and click on related state. Fill out return requested form and submit it online. After Premio receive return request from consumer, we will validate all information provided, a prepaid shipping label and shipping location will be provided to consumer through email. Consumer then follow Premio packing instruction to pack the recycling unit. A toll free number and email are provided on website for further help and assistance. Premio's contracted recycler will then recycle the unit according to state requirement.

10. What information do you provide to consumers on how and where to return covered electronic devices that are labeled with your name or brand label?

We provide step by step recycling process and packing instruction to consumer. Consumer will need to fill out return request form. Pack the recycling unit according to Premio's packing instruction. Print out shipping label and ship the unit to location specified by Premio.
