Congratulations! The Modified Settlement Agreement goal of licensing 1,450 non-relative foster homes by June 30, 2013 was achieved. This outstanding achievement was reached because of all of your hard work and dedication to increasing quality placement options for children in foster care. The final number continues to be reviewed and verified by the Division of Continuous Quality Improvement (DCQI) and is subject to change.

Seventy-two percent of the counties met or exceeded their MSA goals to help DHS meet the 1,450 non-relative licensing goal! Special recognition goes to **Alcona/Alpena/Montmorency, Alger/Marquette/Schoolcraft, Allegan, Arenac/Gladwin, Baraga/Houghton/Keweenaw, Barry, Bay, Berrien, Branch, Calhoun, Charlevoix/Emmet, Cheboygan/Presque Isle, Chippewa/Luce/Mackinac, Clare/Missaukee/Wexford, Clinton/Gratiot, Delta, Dickinson, Eaton, Gogebic/Iron/Ontonagon, Hillsdale, Huron/Tuscola, Ionia/Montcalm, Iosco/Ogemaw/Roscommon, Isabella, Kent, Lake/Newaygo, Lapeer, Lenawee, Livingston, Macomb, Mason/Oceana, Mecosta/Osceola, Midland, Monroe, Muskegon, Oakland, St. Joseph, Shiawassee and Van Buren** counties for meeting or exceeding their non-relative foster home MSA goals.

Keep up the great work as counties move forward with completing their FY13 AFPRR goals.

Adoptions

In FY2013, 77% of the number of children who are legally free for adoption with the goal of adoption as of September 30, 2012 must have adoptions finalized by September 30, 2013. Based on an initial data pull, an estimated 2,200 adoptions must be completed by September 30, 2013 to exceed the 77% goal.

Based upon adoption data provided by the Department of Human Services Data Management Unit, the State of Michigan is currently **20 adoptions** above monthly goals. To focus efforts on achieving the MSA mandate of finalizing 2,200 adoptions by September 30, 2013, DHS county directors and contracted adoption agency directors should meet to identify adoption barriers and develop strategies to overcome the barriers on all assigned adoption cases and to ensure timely entry of adoption finalization data on SWSS.

Relative Licensing Goals

The placement of children with appropriate relatives as out of home caregivers continues to be a priority of the Department. However, all unlicensed relative placements must have at least one of the following, depending on the length of time since a child's placement:

1. A completed and approved home study within 30 days of placement for initial placements; and prior to placement for replacements. Completion and approval dates both must be entered into SWSS.
2. If a relative is pursuing licensure, but is not yet enrolled, the case file should contain a record of the referral date to the licensing worker and an up-to-date status of the licensing process. This information can be input into the licensing database and the referral date can be entered in SWSS.
3. If pursuing a waiver, a completed DHS-875 must be signed by the DHS county director. Completion and approval dates both must be entered into SWSS.

Data reporting on the number of placements with unlicensed relatives continues to be a challenge because many SWSS case records do not reflect an approved home study or waiver, and relatives are not enrolled to be licensed with BCAL. Local office management must use the regularly updated "relative placement" reports on the Child Welfare Field Operations SharePoint site to identify and monitor those cases that require additional data entry or action.

AFPRR Allocations

The purpose of AFPRR funds is to provide financial resources to counties to support and retain current foster and adoptive parents and to recruit new foster and adoptive parents. These funds need to be **used throughout the year** to meet the needs of current foster and adoptive parents, and to recruit foster/adoptive homes to meet the needs of children coming into care. Recruitment activities should focus on recruiting homes for teens, sibling groups, children with disabilities, and specific children waiting for adoption who do not have an identified family as well as to meet additional targeted needs as identified by the county.

Currently, **62%** of AFPRR funds allocated to the field remain unspent. The data from MAIN reflects the amounts of vouchered AFPRR expenditures submitted by counties that have been processed by Central Office. Due to the lengthy payment process, there may be a significant discrepancy between MAIN's AFPRR expenditure records and the local county AFPRR expenditure records. To decrease the discrepancy between MAIN's AFPRR expenditure reports and the local county AFPRR expenditure reports, please submit all payment vouchers and journal vouchers as soon as possible.

Examples of how AFPRR funds can be used to support counties in meeting their non-relative licensing goals:

- A recruitment contract with a current or closed foster/adoptive/kinship parent to plan and implement recruitment activities; respond to inquiries and follow-up with prospective foster/adoptive/kinship families; train PRIDE; plan and implement retention activities; organize and implement a support group and/or foster/adoptive/kinship parent mentoring program.
- Advertise in local newspapers and movie theaters, etc. The Office of Communications is in the process of completing standardized brochures, posters, PSAs, advertisements, etc. for counties to use. Counties will be notified as soon as these items are available.
- Recruiting at local fairs, expos, and community events.
- Recruiting at faith communities.
- Recruiting at local places where families frequent, such as parks, zoos, movie theaters, sporting events.
- Expanding retention activities to include recruitment – asking foster/adoptive/kinship parents to bring interested families to retention activities.

Statewide Foster/Adoptive Parent Tracking Database

A statewide Foster/Adoptive Parent Database was developed and is accessible through the JJOLT system to assist all DHS offices and PAFC partners. The Foster/Adoptive Parent Database assists agencies in tracking follow-up efforts with all foster/adoptive and relative referrals for licensure. The Foster/Adoptive Parent Database also assists in tracking retention, recruitment, and foster/adoptive parent training efforts and activities. The data from this database is used to report licensing, recruitment, and retention activities to the monitors for the MSA. **To ensure the database provides accurate statewide data, it is mandatory that all DHS agencies and PAFC partners utilize the new database.**

Fingerprinting Update

As of June 1, 2013, the statewide contract for fingerprinting foster, adoptive and kinship families is no longer held by Cogent Inc. The new multi-department, statewide fingerprinting contract was awarded to MorphoTrust USA (formally known as L1 Solutions) and was effective 6/1/2013. This is a statewide contract involving the Department of Human Services, Department of Corrections, Department of Community Health and others.

Workers **must** register and schedule fingerprinting appointments for all applicants either online or through the call center **before** the applicants go to the local site for the fingerprinting clearances. Prospective foster, adoptive and kinship families **are not** supposed to schedule their own fingerprinting appointments.

Active sites are added daily. Additional hours of availability for certain sites are being negotiated with the contractor. However, please notify Nicole Leitch at LeitchN@michigan.gov with any concerns or issues with the fingerprinting process.



