The State Court Administrative Office (SCAO), Child Welfare Services Division, with the Department of Human Services (DHS) and the Governor's Task Force on Child Abuse and Neglect (GTF), is pleased to present a regional, cross-professional Specialized Training seminar on **The ICWA "Qualified Expert Witness" Testimony to Protect the Best Interests of the Indian Child.**

This multi-disciplinary training is designed for DHS caseworkers (children's protective services and foster care workers), Judges (state and tribal), referees, other court staff, as well as private agency caseworkers and other DHS child welfare personnel. The purpose of this training is to help child welfare professionals understand the role of the Qualified Expert Witness (QEW) and to provide practice tips on how to effectively present QEW testimony. In addition, it will help judges to evaluate the quality of the testimony as well as further aid attorneys in conducting direct and cross examination of the QEW.

**The Training will take place Wednesday, August 8, 2012 at the Hall of Justice Conference Center, located at 925 West Ottawa Street, Lansing, MI 48909.**

There is no registration fee for this training. DHS employees may attend this training with approval from local office management. The registration deadline is **August 3, 2012**. The registration materials and directions for how to register are in the informational brochure included with this memo. 

# **THE ICWA “QUALIFIED EXPERT WITNESS” TESTIMONY TO PROTECT THE BEST INTERESTS OF THE INDIAN CHILD**

This project was funded by a federal Children’s Justice Act grant to the Governor’s Task Force on Child Abuse and Neglect administered through the Michigan Department of Human Services, under the Child Abuse Prevention and Treatment Act, Administration of Children and Families, Department of Health and Human Services, CFDA 93.643, being sections 107(a), (b), (c), (d), (e), and (f) as amended (42 USC 5101 *et seq.*); and the Victims of Crime Act of 1984, as amended (42 USC 10601 *et seq.*). In addition, this is a joint project of the State Court Administrative Office and the Governor’s Task Force on Child Abuse and Neglect, chaired by the Honorable Elizabeth A. Weaver, retired Justice of the Michigan Supreme Court.

## BACKGROUND AND PURPOSE

Under the Indian Child Welfare Act (ICWA), the “Qualified Expert Witness” (QEW) serves an important role in cases involving Indian children. Due to the limited number of ICWA cases, the QEW’s role and testimony are often misunderstood. This training will help child welfare professionals understand the role of the QEW and will provide practice tips on how to effectively present QEW testimony. This will include testimony on tribal history, tribal perspective on children and childhood, cultural expectations, specific tribal family history, and the unique needs of the Indian child. In addition to improving foundational knowledge on the role of the QEW, the training will also help judges to evaluate the quality of the testimony as well as further aid attorneys in conducting direct and cross examination of the QEW. The morning session will feature a presentation on the role of the QEW in ICWA cases. The afternoon session will offer hands-on exercises demonstrating QEW testimony in an ICWA case.

Judges (state and tribal); referees; other court staff; attorneys; DHS caseworkers; other DHS child welfare personnel; and private agency caseworkers.
