SETTLEMENT AGREEMENT

On September 25, 2014, the Bureau of Children and Adult Licensing (BCAL) issued an *Order of Summary Suspension and Notice of Intent to Revoke* the group child care home license of Lisa Carter-Bates.

In settlement of all issues raised in the *Order of Summary Suspension and Notice of Intent to Revoke*, the undersigned parties hereby agree:

- 1) Lisa Carter-Bates neither admits nor denies the allegations set forth in the *Order of Summary Suspension and Notice of Intent to Revoke*; however, Ms. Carter-Bates admits to a violation of the Child Care Organizations Act or a licensing rule promulgated under the Act.
- 2) Lisa Carter-Bates understands that her group child care home license will be revoked, effective the date of the signature by the representative of the Bureau of Children and Adult Licensing. Ms. Carter-Bates agrees to immediately cease providing care to unrelated children in her home.
- 3) Lisa Carter-Bates understands that under MCL 722.125, Section 15(1), a person who provides child care without a license is guilty of a misdemeanor and punishable by up to 90 days imprisonment and/or a \$1,000 fine.
- 4) Lisa Carter-Bates understands that she is waiving her right to appeal the *Order of Summary Suspension and Notice of Intent to Revoke* her license, and an administrative hearing will not be held in this matter.
- 5) Lisa Carter-Bates agrees not to apply for a license or certificate of registration for a child care organization licensed or registered under the Child Care Organizations Act for a period of two years, and agrees not to be connected, directly or indirectly, with a licensee or registrant for a period of two years from the effective date of this agreement.

6) This agreement does not prohibit Ms. Carter-Bates from being employed in a child care setting outside of her home provided that she does not assume a supervisory position, or the position of registrant, licensee, licensee designee or program director.

7) Should Ms. Carter-Bates apply for a child care license/certificate of registration after October 3, 2016, BCAL agrees that a full and fair assessment of Ms. Carter-Bates' proposed child care facility will be conducted.
