

The Michigan Administrative Hearing System has removed this case from its docket, and closed its file in this matter.


The Settlement Agreement is attached hereto, incorporated by reference into this Order, and transmitted to the Director of the Department of Human Services.

SETTLEMENT AGREEMENT

On April 10, 2014, the Bureau of Children and Adult Licensing issued its Notice of Intent to Revoke License in the above-captioned matter to revoke the adult foster care small group home license of Coventry Homestead, LLC. In settlement of all issues raised in the Notice of Intent to Revoke License, the undersigned parties agree to the following:

- 1) Coventry Homestead, LLC agrees that its Adult Foster Care license, AS020200060, be administratively closed.
- 2) Coventry Homestead, LLC agrees that it is to cease providing adult foster care services immediately upon the date the Director of the Department Human Services signs an Order approving this Settlement Agreement. Coventry Homestead, LLC agrees and understands that under MCL 400.713(1) and MCL 400.713(13), the continued operation of an unlicensed adult foster care facility, including an adult foster care family home, is a misdemeanor punishable by imprisonment for not more than two years, or a fine of not more than \$50,000.00, or both.
- 3) Coventry Homestead, LLC agrees not to apply for an adult foster care license and not to be connected, directly or indirectly, with another adult foster care licensee for a period of five (5) years, effective the date the Director of the Department of Human Services signs an Order approving this Settlement Agreement.

- 4) Anthony Boney, licensee designee for Coventry Homestead, LLC, agrees not to act as a licensee designee or an administrator for another AFC facility for a period of five (5) years, effective the date the Director of the Department of Human Services signs an Order approving this Settlement Agreement.
- 5) In agreeing to the above, Coventry Homestead, LLC waives its right to appeal the Notice of Intent to Revoke License and understands that an administrative hearing will not be held in this matter.
- 6) This agreement is not final until approved by the Director of the Department of Human Services.


