

The Michigan Administrative Hearing System has removed this case from its docket, cancelled the hearing scheduled for January 21, 2015, and closed its file in this matter.


The Stipulation is attached hereto, incorporated by reference into this Order, and transmitted to the Director of the Department of Human Services.

The parties to this administrative appeal, Christina King *in propria persona* and the Bureau of Children and Adult Licensing through its respective counsel, agree to the following:




