


The Settlement Agreement is attached hereto, incorporated by reference into this Order, and transmitted to the Acting Director of the Department of Human Services.




SETTLEMENT AGREEMENT

On November 10, 2014, the Bureau of Children and Adult Licensing issued an *Amended Notice of Intent to Revoke* the group child care home license of Jodi Rowell. In settlement of all issues raised in that *Amended Notice of Intent to Revoke*, the undersigned parties hereby agree:

- 1) Jodi Rowell neither admits nor denies that the allegations set forth in the *Amended Notice of Intent to Revoke* are true.
- 2) Jodi Rowell agrees to the revocation of her group day care home license effective January 31, 2015.
- 3) Jodi Rowell understands that this settlement agreement is effective the date of the signature by the representative of the Bureau of Children and Adult Licensing and cannot be changed after that date.
- 4) Jodi Rowell understands that the administrative hearing scheduled for January 5, 2015 (Docket No. 14-021751) will be canceled and that an administrative hearing will not be held in this matter.
- 5) For two years from the date of the revocation of her group child care license, Jodi Rowell agrees not to (a) apply for a license or certificate of registration for a child care organization licensed or registered under the Child Care Organization Act, and (b) be connected, directly or indirectly, with a licensee or registrant.


