**1. Current percentage of FIP cases involved in JET employment activities:**

The percentage of Family Independence Program (FIP) cases "involved in JET employment activities" for August of 2013 was **65.1%**. **2. Current percentage of FIP cases that meet federal work participation requirement.**

The current percentage of FIP cases that meet federal work participation requirements for FY 2013, year-to-date (October 2012 - June 2013) is **50.79%**. This percentage is calculated by the DHS Office of Quality Assurance.
