


SETTLEMENT AGREEMENT

On July 11, 2013, the Bureau of Children and Adult Licensing issued a *Notice of Intent to Revoke* the adult foster care small group home license of DenBos Care Services, Inc., Licensee.


In settlement of all issues raised in that *Notice of Intent to Revoke*, the undersigned party hereby agrees:

- 1) DenBos Care Services, Inc. neither admits nor denies that the specific allegations set forth in the *Notice of Intent to Revoke* are true, but agrees that at least one violation of the Adult Foster Care Facility Licensing Act, 1979 PA 218, has occurred.
- 2) DenBos Care Services, Inc. understands that their license will be revoked and agrees not to apply for a license for an adult foster care facility licensed under the Adult Foster Care Facility Licensing Act for a period of four (4) years.
- 3) DenBos Care Services, Inc. understands that they are waiving their right to appeal the *Notice of Intent to Revoke* and a hearing will not be held in this matter.
- 4) DenBos Care Services, Inc. agrees to cease the provision of adult foster care services within 30 days of the signature date of the Director of Adult Foster Care Division.
