The Michigan Administrative Hearing System has removed this case from its docket, cancelled the hearing for November 4, 5 and 6, 2014, and closed its file in this matter.


The Settlement Agreement is attached hereto, incorporated by reference into this Order, and transmitted to the Director of the Department of Human Services.

In settlement of all issues raised in that *Notice of Intent to Revoke*, the undersigned party hereby agrees:


