## BIOFUEL SIGNAGE REBATE PROGRAM

To increase public awareness of service stations that offer biofuels (E85 and B20) near Michigan interstate highway exits, and to assess the impact this increased awareness would have on biofuel sales at these stations, the Michigan Energy Office is initiating a rebate program for retail service stations to indicate biofuel availability on highway logo signs, beginning October 1, 2008.

Rebates of up to \$1,500 are available to cover 50% of the costs to design, install, and pay the first year's annual fee for logo signs displaying the availability of ethanol fuel (E85) or biodiesel fuel (B20) at a public service station through the Michigan Department of Transportation's (MDOT's) **Logo Sign Program**. Public service stations throughout Michigan that dispense ethanol (E85) or biodiesel (B20 or higher blend) and are located within six miles of an interstate highway are eligible.

Biofuel Signage Rebate applications must be submitted before September 1, 2009 to qualify for this rebate and reserve the funds. Rebates will be available on a first come basis until available funds are exhausted. Service station owners who received a rebate during the program's first year are eligible to apply for a rebate to cover 50% of the second year's annual fee for the sign. The typical cost for logo signs and the annual fee under the **Logo Sign Program** ranges from about \$2,300 to \$2,800 depending on several factors including the number of colors in the sign, whether the service station has an existing sign that needs modification to display ethanol or biodiesel availability, or a new sign needs to be designed and installed. Michigan Logos staff will help determine your eligibility, complete an application, and design your sign. When your application is accepted, Michigan Logos will arrange for manufacturing, erecting, and maintaining the sign. The sign must specify that **E85** and/or **B20** are offered at the station.

### How do I get my rebate?

1. A completed Biofuel Signage Rebate Program Application Form.
2. Two invoices from the Logo Signing Program - one for the cost of your biofuel sign and one for the first year's annual fee.
