Specially Designated Merchant (SDM)	Sale of beer and wine not exceeding 21% alcohol at retail for consumption off premises	\$100.00	Not applicable
Tavern	Sale of beer and wine not exceeding 21% alcohol at retail for consumption on premises	\$250.00	\$208.33
A-Hotel	Sale of beer and wine not exceeding 21% alcohol at retail for consumption on premises	\$250.00 plus \$1.00 each bedroom in excess of 20, but not to exceed \$500.00	\$208.33 plus \$.83 each bedroom in excess of 20. Each additional bar \$416.67. *
B-Hotel	Sale of beer, wine and spirits at retail for consumption on premises	\$600.00 plus \$3.00 each bedroom in excess of 20. Each additional bar, \$350.00 *	\$500.00 plus \$2.50 each bedroom in excess of 20. Each additional bar \$291.67. *
Class C	Sale of beer, wine and spirits at retail for consumption on premises	\$600.00 plus \$350.00 each additional bar. (In municipally owned or supported facilities in which nonprofit organizations operate concessions stands, additional bar fee is \$100.00) *	\$500.00 plus \$291.67 each additional bar. *
Class G-1	Sale of beer, wine and spirits at retail to members only for consumption on the premises at an 18-hole golf course	\$1,000.00 *	\$833.30
Class G-2	Sale of beer and wine at retail to members only for consumption on the premises at an 18-hole golf course	\$500.00	\$416.65
Brewpub	Manufacture and brew not more than 5,000 barrels of beer per calendar year and sell at retail for consumption on or off the premises issued in conjunction with Class C, Tavern, B-Hotel or A-Hotel license	\$100.00	Not applicable
Club	Sale of beer, wine and spirits for consumption on premises by members	\$300.00 plus \$1.00 each member (based on number of members at time of renewal) in excess of 150. Maximum \$750.00 for any 1 club in addition to any SDM license fee *	Not applicable
Aircraft	Sale of beer, wine and spirits at retail for consumption on premises	\$600.00 * per airline	Not applicable
Trains	Sale of beer, wine and spirits at retail for consumption on premises	\$100.00 per train *	Not applicable
Watercraft	Sale of beer, wine and spirits at retail for consumption on premises	\$100.00 minimum fee and a maximum fee of \$500.00 per year computed on the basis of \$1.00 per person per passenger capacity per watercraft *	Not applicable

* On-Premises and SDD licensees authorized to sell spirits on Sunday after 12:00 noon pay an additional 15% of the total On-Premises or SDD license fee
