**FINAL ORDER DENYING APPLICATION FOR LOAN OFFICER REGISTRATION
AND MICHIGAN SPECIFIC SUPPLEMENT TO FORM MU4**

I.

FINDINGS OF FACT

1. On or about April 14, 2009, the Deputy Commissioner issued to Shelton Blannon a Notice of Denial of Request For Loan Officer Registration and Michigan-Specific Supplement To Form MU4 and Notice of Opportunity for Hearing (Notice) pursuant to the Mortgage Brokers, Lenders, and Servicers Licensing Act, MCL 445.1651 *et seq.* The Notice advised Shelton Blannon that he was ineligible for licensure under Section 2a(6)(a)(i) of the MBLSLA because he had been convicted of a felony or misdemeanor involving a financial transaction. OFIR served the Notice on Shelton Blannon via certified mail, and further advised Shelton

Blannon that he had 20 days from the issuance of the Notice to request a hearing to contest the Notice.

2. Shelton Blannon contacted the Deputy Commissioner's Hearing Clerk on April 24, 2009 and stated he would like to schedule a hearing.

3. On May 5, 2009, the Deputy Commissioner's Hearing Clerk sent Shelton Blannon a letter advising him that the Deputy Commissioner's Hearing Clerk had received his request to schedule a hearing to appeal the denial of his application for Loan Officer Registration in Michigan. The letter advised Shelton Blannon that he was to complete the enclosed "Applicant's Petition For Contested Case hearing To Appeal Agency Denial Of Application For Loan Officer Registration And Michigan Specific Supplement To Form MU-4" (the "Application") and return it to the Deputy Commissioner's Hearing Clerk within 20 days.


4. Shelton Blannon never completed the Application.
