Bay City Public Schools Bid Package No. 12 will consist of interior renovation for nearly all architectural trades. Trades involved will be demolition, excavation, concrete, masonry, structural steel, miscellaneous steel, carpentry, lockers, miscellaneous roofing, glass, drywall, acoustic ceilings, carpet, terrazzo, painting, elevator, fire protection, mechanical and electrical. The building covers approximately 250,000 square feet.

Sealed bid proposals will be received from Trade Contractors submitting only complete bids on a Bid Category.

**Bay City Public Schools will receive sealed bid proposals until 2:00 pm EDT on March 27, 2007** at Bay City Public Schools, Maintenance Building, 4721 S. Three Mile Road, 48706, Attn: Dave Mrozinski. Bids to be submitted in duplicate. All bids must be submitted on the bid proposal form provided with these documents. All bid proposals will be publicly opened and read aloud immediately following. **Bid proposals must be delivered to Bay City Public Schools.** Fax bids will not be accepted by Bay City Public Schools. No bids will be accepted at the office of the Construction Manager or Architect.

Bidders may obtain bidding documents (plans and project manual) at the office of the Construction Manager: Spence Brothers, 417 McCoskry Street, Saginaw, Michigan 48601 (Phone: 989-752-0400 // Fax: 989-752-8769) on or about March 6, 2007. **A refundable plan deposit of \$100.00 per set will be required for printed documents.** Check to be made out to Bay City Public Schools. A CD of the documents can be obtained at no cost to the contractor. Plans may be examined at the Tri-City Builder's Exchange, F. W. Dodge in Detroit, CAM, Central Michigan Plan Room, Builders Exchanges in Lansing and Grand Rapids, Construction News Service, or may be examined at the Spence Brothers' plan room. **All questions need to be submitted to the Construction Manager no later than March 20, 2007.**

A **Pre-Bid Conference** for all trades will be conducted at Central High School at **3:00 pm EDT on Thursday, March 8, 2007**. Meet at the cafeteria for the High School. The Owner, Architect and Construction Manager will provide a tour of the site and questions will be entertained regarding the bidding process, construction schedule, site conditions and any other related matters.

Prevailing wages will be required to be paid by all contractors on this project. Owner and Construction Manager will require certified payroll.

A bid bond will be required in the amount of 5% of the bid, if the bid amount exceeds \$50,000.

Substantial completion date for the work in each Bid Category shall be as indicated in the Milestone Schedule in the Construction Manager's Project Manual.

Bay City Public Schools reserves the right to accept and/or reject any or all bid proposals and to waive any and all informalities and/or irregularities in bid proposals submitted. This right shall be exercised at the sole discretion of Bay City Public Schools. Bay City Public Schools will make award as may appear to be in the best interest of the Bay City Public Schools
