



**NOTICE TO BIDDERS**

Comstock Public Schools, Kalamazoo, Michigan, will receive proposals from qualified flooring contractors for Carpet Replacement at Northeast Middle School and North Elementary, located at 1423 N. 28<sup>th</sup> Street, Kalamazoo, Michigan and 3100 N. 26<sup>th</sup> Street, Kalamazoo, Michigan, respectively.

Flooring Contractor bids are open to qualified bidders and shall be bid separately. The Owner will enter into contract with the successful Flooring Contractor, who shall be fully responsible for all work required to complete the project, for the work of all trades, and for coordination of all work among trades.

Note: Where “contractor” is referred to in these specifications, this shall be interpreted to refer to the Flooring Contractor unless noted otherwise.

Proposals must be mailed or delivered in person to Mr. Todd Mora, Comstock Public Schools, 3010 Gull Road, Kalamazoo, MI 49048. All proposals must be sealed in envelopes, plainly labeled “Northeast Middle School and North Elementary Carpet Replacement” and must be received prior to **11:00 A.M.**, local time, on **Wednesday, June 20, 2007**. This will be a public bid opening. Contractors will be notified within the allocated period of time as to their position in the bid process. Evaluation of proposals and award will be at a later date; the successful contractor will receive a letter of intent prior to receipt of contract.

A mandatory pre-bid meeting will be held at 10:00 A.M., local time, on Thursday, June 14, 2007 at Northeast Middle School (project site), located at 1423 N. 28<sup>th</sup> Street, Kalamazoo, Michigan.

The Schedule of Work shall be as follows:

**June 20, 2007**

**Bids Due**

Intent to award contract within two weeks after Bid Due date

**July 1, 2007**

**Anticipated start of construction**

**August 22, 2007**

**Anticipated substantial Completion**

All bidders are required to furnish Bid Security in the amount of five (5%) percent of the Base Bid. Form of the security may be a bid bond, certified or cashiers check made payable to Comstock Public Schools. This will be a guarantee that the bidder selected by Comstock Public Schools will furnish the required PLM Bonds; failure to do so could mean forfeiture of the Bid Security.

All bidders must indicate, where shown on the Proposal Form, the cost of Performance and Labor and Material Payment Bonds covering 100% of the value of the Project. Do not include the cost of the Bonds in the Base Bid.

Prospective Bidders desiring complete sets of Contract Documents may obtain them from the Architect/Engineer. A deposit of \$100.00 per set will be required for requests of over five (5) sets. Any shipping and handling charges must be paid by requesting party. The document deposit will be refunded in full if the documents (Plans & Specifications) are returned in good condition within 14 days after the bid opening and the Contractor submitted a bid. Contractors declining to bid must return the construction documents five (5) days prior to bid opening in order to receive their deposit.
