Oral, telephone, fax or electronic mail bids are invalid and will not receive consideration. Bid proposals received after this time will not be accepted.

All bids will be publicly opened and read aloud at 12:15 P.M., E.D.S.T., December 28, 2007 at the Conner Creek Academy East, Gymnasium, 16911 Eastland, Roseville, Michigan 48066.

Proposals must include a bid bond or certified check for not less than five percent of the contract and must be submitted with the bid proposal forms furnished with the specifications. Successful bidders will be required to provide Labor, Material and Performance Bonds for 100% each of contract award, issued by sureties listed by the Treasury Department, as listed in U.S. Dept. of Treasury Circular 570, and licensed to do business in Michigan. Performance bonds are required for all proposals greater than \$50,000.

All contracts to be entered into with Conner Creek Academy East must and will comply with the equal opportunity laws and the Requirements of Michigan Public Act 166 of 1965, Prevailing Wage rates of the State of Michigan.

All bidders must provide familial disclosure in compliance with MCL 380.1267 and attach this information to the bid proposal. The bid proposal will be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner or any employee of the bidder and any member of the Conner Creek Academy

East Board or the Conner Creek Academy East Superintendent. The Board will not accept a bid proposal that does not include this sworn and notarized disclosure statement.

The Board of Directors reserves the right to accept or reject any or all bids, either in whole or in part; to award contract to other than the low bidder; to waive any irregularities or informalities; and in general to make awards in any manner deemed to be in the best interests of the Board.
