



NOTICE TO BIDDERS

Ionia Public Schools, Ionia, Michigan, will receive proposals from qualified contractors for Ionia High School Pool System Remodeling, located at 250 E. Tuttle Road, Ionia, Michigan 48846.

The Owner will enter into separate contracts with the successful Pool and Mechanical Contractors.

Note: Where “contractor” is referred to in these specifications, this shall be interpreted to refer to the General, Mechanical, Pool or Electrical Contractor, unless noted otherwise.

Proposals must be mailed or delivered in person to Mr. Don Wilcox, Ionia Public Schools, Administrative Offices, 250 E. Tuttle Road, Ionia, Michigan 48846. All proposals must be sealed in envelopes, plainly labeled “Ionia High School Pool System Remodeling” and must be received prior to **11:00 A.M., local time, on Monday, March 26, 2007**. This will be a public bid opening. Evaluation of proposals and award will be at a later date; the successful contractor will receive a letter of intent prior to receipt of contract.

There will be no pre-bid meeting.

The Schedule of Work shall be as follows:

All bidders are required to furnish Bid Security in the amount of five (5%) percent of the Base Bid made payable to Ionia Public Schools. Form of the security may be a bid bond, certified or cashiers check. This will be a guarantee that the bidder selected by Ionia Public Schools will furnish the required PLM Bonds; failure to do so could mean forfeiture of the Bid Security.

All bidders must indicate, where shown on the Proposal Form, the cost of Performance and Labor and Material Payment Bonds covering 100% of the value of the Project. Do not include the cost of the Bonds in the Base Bid.

All bids shall be accompanied by a sworn statement disclosing any familial relationship that exists between the owner(s) or any employee of the bidder and any member of the Board of Education of the School District or the Superintendent of the School District. The Board of Education shall not accept a bid that does not include a sworn and notarized familial relationship disclosure statement.



Applicable Michigan use and sales tax apply to this project.

All bidders should note that this project requires prevailing wages, which are included herein.
