The Board shall require each bidder for a contract under this policy, to file with the Board security in an amount not less than 1/20 of the amount of the bid conditioned to secure the District from loss or damage by reason of the withdrawal of the bid or by the failure of the bidder to enter a contract for performance, if the bid is accepted by the Board. All bids will be opened publicly and read aloud at the administrative office on Thursday, February 21<sup>st</sup> at 2 PM.

**Bidders should attend a Pre-bid Conference at 10:30 A.M, Thursday, February 14, 2008 at the Administrative Offices.**

Contractors will be notified of the outcome of the proposals at the Owner's earliest convenience. Proposals shall be submitted in triplicate.

## PROPOSAL REQUIREMENTS AND CONDITIONS:

1. All alarm panels, devices and equipment will be as manufactured by Edwards System Technology, Inc. or SimplexGrinnell. Other manufactures will not be considered.
2. Prevailing wage rates will not apply to this project.
3. Separate proposals shall be submitted for the Middle School and the Elementary School.
4. Any access to the school buildings shall be scheduled through the Superintendent's Office.
5. All bidders shall familiarize themselves with the existing building conditions prior to the pre-bid conference meeting.
6. Kitchen roll up shutters shall be reviewed for compliance with State Office of Fire Safety requirements.
7. Cross corridor doors shall be provided with hold open devices in compliance with the Office of Fire Safety requirements.
8. The Contractor will provide a complete, finished and operating system, which will include providing skilled tradesman from any trade that may be required.
