

ADVERTISEMENT FOR BIDS

Mount Clemens Cairns Field Educational Center

The Board of Education of the Mount Clemens Community Schools will receive single prime sealed bids for the Mount Clemens Cairns Field Educational Center Project (located on the south side of Clemens Street, between Orchard Street and North Walnut Street) by mail or hand delivery, on or before **Friday, April 27, 2007 at 2:00pm**. Bids received after this date and time or bids received via facsimile or by electronic transmission will not be considered or accepted. Bids shall be submitted to the Mount Clemens Community Schools, attention Venkat Saripalli, Assistant Superintendent for Business Services, 167 Cass Avenue, Mount Clemens, MI 48043. Submit two (2) complete copies of bid submittal. Bids received will be publicly opened and read aloud starting at 2:15pm on Friday, April 27, 2007.

The project includes the construction of a new approximately 9,650 SF, single story facility. Various site improvements in the immediate area of the facility are also included as part of this project.

Bid documents will be available on or about April 6, 2007. Contact the Architect's Office for availability. The Architect will provide up to two (2) complete bid sets for cost of \$100.00 (non-refundable) per set. Additional bid sets are available at direct cost to the bidder. Checks shall be made payable to: Mount Clemens Community Schools.

There is a non-mandatory pre-bid walkthrough at the Mount Clemens Community Schools Business Office on **Wednesday, April 18th @ 2:00 p.m.** The Business Office is located at 167 Cass Avenue, Mount Clemens, MI 48043.

Make proposals on the bid form supplied in the specifications manual. No oral or telegraphic proposals or modifications will be considered. Submit with each bid, a certified check or acceptable bid bond payable to Mount Clemens Community Schools, in an amount equal to five percent (5%) of the total bid. For bids in excess of \$50,000, a Labor and Material Payment Bond and a Performance Bond will be required.

All bids shall be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner(s) or any employee of the bidder and any member of the Board of Education or the Superintendent of the Mount Clemens Community Schools. **A bid that does not include this document will not be accepted.**

Bids may not be withdrawn for a period of ninety (90) days after the scheduled time of opening bids. The Board reserves the right to accept or reject any or all bids received, either in whole or in part and to waive any irregularities or informalities therein or to award the bid to other than the low bidder, in its sole discretion.
