The Board of Education, New Haven Community Schools, New Haven, Michigan, will receive sealed bids for Siefert Elementary School.

Separate prime bids for the following categories will be considered:

- Base Bid "A" – Network Electronics
- Base Bid "B" – Video Distribution System

The Board of Education will receive bids until 1:00 pm on May 29th at New Haven Community Schools 58233 Gratiot New Haven, MI 48048 Bids received after this time will not be accepted. Bids will be opened and publicly read aloud all interested parties are invited to attend.

Successful bidders shall conform to the "Schedule of Prevailing Wages" included after the Supplementary Conditions.

A bid security in the form of AIA Document A310, a certified check, "Contractors Combination Bid Bond and Bond for Construction," or a form from an acceptable surety shall accompany each bid. The bid security shall be in the penal amount of 10 percent of the total bid. Bid security shall be forfeited if bid is withdrawn after closing time on date for receiving bids.

All bids shall be accompanied by a sworn statement disclosing any familial relationship that exists between the owner(s) or any employee of the bidder and any member of the Board of Education of the School District or the Superintendent of the School District. The Board of Education shall not accept a bid that does not include a sworn and notarized familial relationship disclosure statement.

Successful bidders are required to furnish a satisfactory Performance and Payment Bond from an acceptable surety in an amount equal to 100 percent of the full contract sum.

Bidders may obtain copies of the documents from the Architect by depositing \$100.00 for each complete set of documents. No partial sets will be issued by deposit. Deposits are to be payable to Fanning Howey and shall be sent or delivered to the requester. Deposits are non-refundable.

A prebid conference will be held at the New Haven Community Schools 58233 Gratiot New Haven, MI 48048 on May 15, 2007 at 1:00 PM local time. Attendance by bidders is **Mandatory**, in order to clarify or answer questions concerning the Drawings and Project Manual for the Project. If another site visit is required to acquire additional information it must be schedule with the school with a **two day** advanced notice.

The Owner reserves the right to reject each and every bid, and to waive informalities, irregularities, and errors in the bidding to the extent permitted by law. This includes the right to extend the date and time for receipt of bids.
