Witnesseth, That the said party of the first part, for and in consideration of the sum of One Dollar and other valuable consideration

has granted, sold, conveyed, confirmed, released and forever QUIT-CLAIM unto the said party of the second part, its heirs and assigns, Forever, All

that Greenfield Township of Wayne County of Michigan and State of Michigan,

known and described as follows:

A parcel of land situated in Section 2 of Greenfield Twp., City of Detroit, Wayne County, State of Michigan, being part of the property now known as the Michigan State Fair Grounds and more particularly described as follows: Beginning at a point where the South line of the Eight Mile Road (now 204 feet wide) intersects the Westerly right of way line of the Grand Trunk Western Railroad Company, said point being 38.00 feet Westerly at right angles from the center-line of the Westbound main track of said Railroad Company as now located; thence Westerly along the South line of the Eight Mile Road a distance of 28.65 feet; thence Southerly parallel to and 25.00 feet at right angles from the Westerly right of way line of said Railroad Company a distance of 159.96 feet; thence Southeasterly a distance of 110.43 feet to a point on the Westerly right of way line of said Railroad Company, said point being 38.00 feet Westerly at right angles from aforesaid center line of West bound main track and 263.52 feet Southerly from the South line of the Eight Mile Road, measured along said Westerly right of way line of said Railroad Company; thence Northerly along said Westerly right of way line a distance of 263.52 feet to place of beginning, containing 5,418.50 square feet or 0.1244 acres.

Including all reversionary rights in and to that portion of the Eight Mile Road adjacent to the Northerly line of the above described parcel and being a strip of land 25.00 feet wide extending from the South line to the center line of said Eight Mile Road.
