- Be a Michigan resident and a member of the Michigan National Guard;
- Be eligible for the Reserve Benefits under the Montgomery GI Bill;
- Maintain satisfactory academic progress at Ferris State University.
- Must complete a current year Financial Aid Application (FAFSA).

### How to apply?

- Apply for admission to a degree-granting program at Ferris State University.
- Complete the attached FSU Michigan National Guard Grant Application Form to apply for funds for Fall and/or Spring Semesters.
- Complete a current Financial Aid Application (FAFSA) and send it to the Federal Processor;
- Have a Michigan National Guard representative verify on the application form that you are a member of the Michigan National Guard and qualify for Reserve Benefits under the Montgomery GI Bill and forward the application to the State Education Office.
- Deadline dates for filing: Fall Semester-August 15, Spring Semester-December 15
