Lake Superior State University is pleased to offer this educational opportunity to all active drilling Michigan National Guard members eligible under National Guard Federal Tuition Assistance. It is available at our main campus in Sault Ste. Marie, as well as at our regional centers in Dearborn, Escanaba, Gaylord and Petoskey.

Essentially, the program takes the stipend you receive through the National Guard Federal Tuition Assistance program, which is intended to partially cover the costs of taking college courses, and accepts that stipend as full payment for tuition.

This agreement builds upon LSSU's military tradition as a converted military base. The school, which is on the site of former US Army Fort Brady, was opened in 1946 in part to help serve the many veterans who were enrolling in colleges after World War II.
