Subject: Order to Regulate the Use of Lands in the Roscommon Management Unit, Ogemaw County
Land Use Orders of the Director Amendment No. 1 of 2008

Authority:

The Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, authorized the Director to issue orders to implement land use rules.

Discussion and Background:

This amendment to Land Use Order of the Director 4.36 is needed to open an otherwise closed forest road to provide connection to the Rose City Road which is a county road maintained by the Ogemaw County Road Commission. This road opening will be beneficial to residents in Klacking Township. Klacking Township and the Ogemaw County Road Commission have requested this change to the Land Use Orders of the Director. The request has been reviewed and recommended for approval by Department staff.

Any road improvement costs and future maintenance costs will be at the expense of either the Township or the County Road Commission. If the road is not properly maintained, the Department may again close the road through an amendment to the Land Use Order of the Director.

Recommendation:

This order was submitted for information on February 7, 2008, at the Natural Resources Commission meeting. This item appeared on the Department's January 28, 2008, calendar and may be eligible for approval on March 6, 2008.

LAND USE ORDERS OF THE DIRECTOR

Amendment No. 1 of 2008

By authority conferred on the Director of the Department of Natural Resources by Section 504 of Act No. 451 of the Public Acts of 1994, as amended, being section 324.504 of the Michigan Compiled Laws and in accordance with R 299.671 and R 299.922 of the Michigan Administrative Code, the Director of the Department of Natural Resources orders that the following order of the Land Use Orders of the Director shall read as follows:

4.36 Certain state-owned lands, Ogemaw county, wheeled motorized vehicles, prohibited conduct.

Order 4.36. (1) A person shall not operate a wheeled motorized vehicle except for otherwise lawful operation upon a designated trail or designated route within:

- (a) The area known as preacher's hill in the S $\frac{1}{2}$ of the SE $\frac{1}{4}$ of section 28, T23N R1E.
- (b) The area along Rose city road in the N $\frac{1}{2}$ of the NW $\frac{1}{4}$ of section 3, except for the forest road which merges onto Rose city road at the eastern edge of the parcel; the N $\frac{1}{2}$ of the NE $\frac{1}{4}$ of section 4, T23N R2E.
- (c) The S $\frac{1}{2}$ of section 27, and the SE $\frac{1}{4}$ of section 28, T23N R2E.
