Subject: Order to Regulate the Use of Lands in the Grayling Management Unit, Crawford County
Land Use Orders of the Director, Amendment 4 of 2008
FOR INFORMATION ONLY

Authority:

The Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, authorized the Director to issue orders to implement land use rules.

Discussion and Background:

This amendment to Land Use Order of the Director 4.16, is needed to correct a technical error in the legal description. The legal description originally approved in 4.16 (5) included section 8, T25N-R01W. This part of the order should be corrected to read section 18, not section 8. As written, the current order is not enforceable for Section 18.

Recommendation:

This amendment is being submitted for information and consideration. This item will appear on the Department's February 25, 2008, calendar and may be eligible for approval in April, 2008.

LAND USE ORDERS OF THE DIRECTOR

Amendment No. 4 of 2008

By authority conferred on the Director of the Department of Natural Resources by Section 504 of Act No. 451 of the Public Acts of 1994, as amended, being section 324.504 of the Michigan Compiled Laws and in accordance with R 299.671 and R 299.921 of the Michigan Administrative Code, the Director of the Department of Natural Resources orders that the following order of the Land Use Orders of the Director shall read as follows:

4.16 Certain state-owned lands, Crawford county, motorized vehicles, camping, entry, prohibited conduct.

Order 4.16. (1) A person shall not operate a motorized vehicle upon the state-owned lands within the S $\frac{1}{2}$ of the SE $\frac{1}{4}$ of section 10, the W $\frac{1}{2}$ of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of section 11, the N $\frac{1}{2}$ of the NE $\frac{1}{4}$ of section 15, and the W $\frac{1}{2}$ of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of section 14, T27N R4W.

(2) A person shall not camp or use a motorized vehicle within the S $\frac{1}{2}$ of the SE $\frac{1}{4}$ of section 30 and the N $\frac{1}{2}$ of the N $\frac{1}{2}$ of the NE $\frac{1}{4}$ of section 31, T27N R1W, also known as the Crawford county red pine tract.

(3) A person shall not operate a wheeled motorized vehicle upon state-owned lake shore and hills surrounding duck lake within the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ and the N $\frac{1}{2}$ of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of section 9, T27N R2W. This prohibition shall not apply to otherwise lawful operation upon a designated trail or designated route in this area.

(4) A person shall not operate a wheeled motorized vehicle upon state-owned lake shore and hills surrounding big frog lake and little frog lake within the W $\frac{1}{2}$ of the SW $\frac{1}{4}$ of section 5, T27N R2W. This prohibition shall not apply to lawful use of a designated trail or designated route in this area.

(5) A person shall not do any of the following on state forest lands bordering the AuSable river in the south branch AuSable river area, known as the Mason tract, being all or portions of sections 29, 31 and 32, T26N R1W; sections 6, 7, and 18, T25N R1W; and sections 13, 14, 22 and 23, T25N R2W:

(a) Camp, except in designated campgrounds.

(b) Operate bicycles on the Mason tract hiking & skiing pathway.

(6) A person shall not enter certain state-owned military lands, commonly referred to as the range 40 complex, being all or portions of sections 3 through 10 and sections 16 through 20, T28N R2W; sections 1, 12, 13, and 24, T28N R3W; section 32, T26N R4W, and sections 5 through 8, T25N R4W, Crawford county.

(7) A person shall not enter the state-owned military range 30 lands, being all or portions of sections 17 through 20, 29 and 30, T27N R2W, and sections 13, 23 through 27, 34, 35, and 36, T27N R3W.

(8) A person shall not camp within 1/4 mile of the big creek impoundment located in sections 24 and 25, T28N R1W.

(9) A person shall not possess a dog or allow a dog to enter upon either the land or water area of the state-owned shoreline located upon the south shore of Lake Margrethe, camp Grayling maneuver training center, T26N R4W, Crawford county.

This order may be posted on or after April 10, 2008.
