Subject: Notice of Estimated Payments in Lieu of Taxes
DNR Land Transaction #20110166

In accordance with Public Act Numbers 240 and 294 of 2012, this notice is being provided to you as the Treasurer of the local taxing unit where the Department of Natural Resources is acquiring new public land. These Public Acts require the Department to estimate the amount of annual payments in lieu of taxes (PILT) on public lands that it is acquiring, and to provide that information to you at least 30 days before the acquisition. Please note that these are only estimates. The Department does not have the authority to determine the valuation of real property for the purposes of the annual PILT payments. Per MCL 324.2153 this authority lies with the State Tax Commission.

The following is a breakdown of the Department's estimate of annual PILT payments for public lands where Act 451 of 1994, Part 21, Subpart 14 directs the State to make these payments and for those lands where Subpart 13 directs the payment of taxes on tax reverted, recreation, and forest lands that are not covered under Subpart 14.

Subpart 13 – Estimated tax on tax reverted, recreation, and forest lands: \$0.00.

Subpart 14 - Estimated Annual PILT Payments: \$2120.00.

Also, for your information I have attached a copy of a memo that summarizes this acquisition of public land within your jurisdiction.

Purchase: 40 acres, more or less. \$85,000.00

This parcel is south of the Mason-Arenac County line and will not result in an increase of counted acres.
Excluded Acres:
40 acres – accessing other land owned by the Department.

Description: Lake County, Cherry Valley Township, T18N, R12W, Section 5, NE ¼ of the SW ¼.

Seller(s): Jeffrey Smith, Ross Bolman, and Timothy Haley of Holland, MI.

Authority: Act 451, Public Acts of 1994, as amended

Notice: This item will appear on the Department of Natural Resources (Department) September 4, 2012, calendar, and is eligible for approval on September 12, 2012.

Comments: The offered parcel is located in Lake County, approximately 7 miles northeast of Baldwin and within the Cadillac Management Unit. The parcel contains the following attributes, which collectively make this a priority acquisition:

- Adjacent State-owned land – bordered by State-owned land on three and one-half sides.
- Project boundary – the property is located within the Cadillac Management Unit project boundary.
- Access – access for the public and department staff will be via a two track road that crosses the adjacent State-owned land and this parcel as it travels to State-owned land along the east side of the Baldwin-Luther swamp.
- Topography – mostly level to gently rolling. Approximately 40% of the land is well drained and 60% is poorly drained.
- Cover – the entire property is wooded.

August 10, 2012

Since the tract is bordered by State Forest land on three and one-half sides, acquisition by the Department will result in a net reduction of $\frac{3}{4}$ mile of property boundary that staff will need to monitor and maintain.

The sellers will remove all structures from the property prior to closing and convey any mineral rights that they own relative to this parcel.

Acquisition of this parcel will contribute to the Department's goals of consolidating State ownership, securing wildlife habitat, enhancing forest management, and increasing public recreation opportunities.

Recommendation: That the acquisition be approved, with payment to be made from the Michigan Natural Resources Trust Fund, Northern Lower Peninsula Eco-Regional Land Consolidation project.


