Subject: Order to Regulate Use of Designated Portions of State Game Areas Regarding
Horses and Pack Animals
Land Use Order of the Director Amendment No. 8 of 2013

Authority:

The Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, authorizes the Director to issue orders to implement land use rules.

Discussion and Background:

Horseback riding has been a popular public recreational activity within the Allegan State Game Area (SGA) for many years. The Allegan County Equestrian Trail System (ETS) was established to make the area more accessible for equestrian use and to protect sensitive ecosystems. The ETS is comprised of over 50 miles of marked and mapped designated riding trails created through a collaborative agreement between Allegan County Parks, the Michigan Department of Natural Resources (DNR), and Friends of the Allegan County Equestrian Trail System (FACETS).

In the interest of public safety and to ensure a positive hunting experience, the ETS is annually closed during firearm deer season. This rule was previously in effect as part of a closure to Allegan SGA special-use areas. Although with the creation of the trail system, the SGA no longer has special-use areas. Accordingly, the Department is updating the order language to be specific to the trail which keeps the closure in alignment with the use agreement under Allegan County Parks.

This proposed amendment is simply technical language to more accurately reference the trail and does not change current use.







LAND USE ORDERS OF THE DIRECTOR

Amendment No. 8 of 2013

By authority conferred on the Director of the Department of Natural Resources by Section 504 of the Natural Resources Environmental Protection Act, 1994 PA 451, as amended, MCL 324.504, and in accordance with R 299.921 to R 299.933 , the Director of the Department of Natural Resources orders the following:

3.17 Designated portions of state game areas, horses and pack animals prohibited at certain times.

Order 3.17 A person shall not possess a horse or other riding, driving, or pack animal within the following southern Michigan SGAs during the dates specified:

- (1) On the designated horseback riding trail in the Barry SGA, Barry county, from October 1 through January 1.
- (2) On the designated ~~special use areas~~ equestrian trail system in the Allegan SGA, Allegan county, from November 15 through November 30.

This amended order shall be posted on or after 12th day of April, 2013.
