



## *BEYOND BOW PHEASANT HUNT!*

### **For Beginners!**

This is a 3 bird limit walk-up hunt hosted by Hunters Creek Club! We will start the day with safety orientation and then practice shooting trap with one on one certified instruction provided by Hunters Creek Club staff! Extra attention will be given to those who have never shot or bird hunted before - Beginners are welcome!

Lunch will be served in the dining room, and then we will head out to the field for a guided walk-up hunt with dogs.

For this hunt, you will need a small game license or apprentice license. For license information, visit: [www.michigan.gov/dnr](http://www.michigan.gov/dnr).

**Hunter orange as your outermost clothing is required by law. BOW will have orange vests available for you to borrow.**

If you do not own a shotgun, BOW will provide one for your use. Please indicate on the registration form if you need to borrow a shotgun. Eye and ear protection for trap shooting will also be provided.

**Your target load shells for trap shooting in the morning are provided by Federal Ammunition.** For the pheasant hunt in the afternoon, you will need to purchase one box of field load. For your convenience, ammunition may be purchased at the Hunters Creek Pro Shop. Ammunition for the pheasant hunt is not included in the registration fee. If you are borrowing a shotgun from BOW, it is recommended that you purchase your field ammunition from the club in order to avoid having the wrong kind of shells for the firearm you will be using.

Please note: birds must be cleaned by Hunters Creek staff. You may not take birds with you that are not cleaned.

\*\* It is customary (not required) to tip your guide and they do appreciate it.
