As required by State Law (P.A. 232 of 2004), all proposals/bids must be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the Owner or any employee of the bidder and any member of the Greenville Public Schools School Board or the Superintendent of the School District. The Board will not accept a bid that does not include this sworn and notarized statement.
