### **Baseem Wahab, OD- Petition for Reinstatement**

MOTION by Peterson-Klein, seconded by Powers, to grant reinstatement if the following is obtained within six months: Petitioner is to successfully complete a total of 18 hours of continuing education in the areas of pharmacology, ocular and systemic disease, two of the 18 hours must be in pain management. The required continuing education must be approved by the Council on Optometric Practitioner Education and must be taken in-person (excludes online and webinars). If the Petitioner fails to submit the required continuing education within six months, his license shall remain revoked. Upon reinstatement of Petitioner's license, Petitioner shall be placed on probation for one year commencing on the date the license is reinstated. Terms of probation include compliance with the Public Health Code.
