Chairman Deloney called the hearings to order at 10:08 a.m., noting a quorum was present.

1. Moved by Commissioner Olshove, supported by Commissioner Quimby, that the minutes of the Southfield Appeal Hearing of September 27, 2012, be approved as written and presented, motion carried by unanimous vote.
2. Discount Beer & Wine, Inc. 1390 E. Bristol, Burton, Genesee County Business ID# 215580

The penalty hearing was conducted for Discount Beer & Wine, Inc., D/B/A Discount Beer & Wine, Inc., Business ID# 215580. Rosendo Asevedo appeared on behalf of the Attorney Generals Office, Attorney Joseph Shallal, David N. Yono, President and Donovan Yono, Manager, appeared on behalf of the licensee. Mr Asevedo, Mr. Shallal and Mr. Yono offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to suspend the licenses for two (2) consecutive days, with the suspension being served on October 9 and 10, 2012. Commissioner Olshove supported, and the motion was carried by unanimous vote.

3. Fars Fill Up Inc., 13500 W. Eight Mile, Oak Park, Oakland County Request ID# 620590

The hearing was conducted for Fars Fill Up Inc., Request ID# 620590. Rosendo Asevedo appeared on behalf of the Attorney Generals Office and Attorney Joseph Shallal appeared on behalf of the applicant. Mr. Asevedo and Mr. Shallal offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated August

15, 2012, and to approve the request as set forth in the Licensing Appeal Order, for a new Specially Designated Merchant license with Sunday Sale Permit (A.M.) and permission for motor vehicle fuel pumps on or adjacent to the licensed premises under MCL 436.1541(1). Commissioner Olshove supported, and the motion was carried by unanimous vote.

4. Market Street Liquor & Wine Shop, Inc., 45338 Market, Shelby Township, Macomb County Request ID# 531227

The hearing was conducted for Market Street Liquor & Wine Shop, Inc., Request ID# 531227. Rosendo Asevedo appeared on behalf of the Attorney Generals Office and Attorney Peter Abbo appeared on behalf of the applicant. Mr. Asevedo and Mr. Abbo offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to affirm the previous Commission Order of denial dated June 22, 2012, and deny the request as set forth in the Licensing Appeal Order, for a new Specially Designated Distributor license with authorization for the sale of spirits for consumption off the premises on Sunday after 12:00 Noon, to be held in conjunction with existing 2012 Specially Designated Merchant license with Sunday Sales Permit (A.M.) and Beer and Wine Sampling Permit. Commissioner Olshove supported, and the motion was carried by unanimous vote

With no further business, moved by Commissioner Olshove, supported by Commissioner Quimby, that the Appeal Hearings be adjourned at 10:50 a.m., motion carried by unanimous vote.
