Chairman Deloney called the hearings to order at 10:09 a.m., noting a quorum was present.

1. Moved by Commissioner Olshove, supported by Commissioner Quimby, that the minutes of the Southfield Appeal Hearing of February 7, 2013, be approved as written and presented, motion carried by unanimous vote.
2. Sullivan Marketing, Inc., MBS International Airport, 9200 Garfield, New Terminal Building, Freeland, Tittabawassee Township, Saginaw County
Request ID# 668990

The licensing hearing was conducted for Sullivan Marketing, Inc., Request ID# 668990, which was tabled from the Appeal Hearing held on January 10, 2013. Rosendo Asevedo appeared on behalf of the Attorney Generals Office, Attorney John F. Fleming and Jeffrey Nagel, Airport Commission, appeared on behalf of the applicant. Mr. Asevedo, Mr. Fleming and Mr. Nagel offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse that part of the previous Commission Order of denial dated October 31, 2012, and approve the request as set forth in the Licensing Appeal Order, to transfer location of 2012 Class C license in the area measuring 125' x 136'. Commissioner Quimby supported, and the motion was carried by unanimous vote.

3. R & J Yaldo, Inc., 640 Auburn, Pontiac, Oakland County Request ID# 629787

The licensing hearing was conducted for R & J Yaldo, Inc., Request ID# 629787, which was tabled from the Appeal Hearing held on August 2, 2012. Rosendo Asevedo appeared on behalf of the Attorney Generals Office and no one was present on behalf of the applicant. Mr. Asevedo gave a brief summary of this case and advised that the applicant has asked for numerous postponements. After discussion on the record, Chairman Deloney advised this matter would be rescheduled for a hearing on Thursday, February 28, 2013.

4. V/8 Bar & Grill, LLC, 20840 Van Dyke, Warren, Macomb County
Request ID# 655379

The licensing hearing was conducted for V/8 Bar & Grill, LLC, Request ID# 655379. Rosendo Asevedo appeared on behalf of the Attorney Generals Office, Attorney Frank Palazzolo and applicant member Jeannette Charara appeared on behalf of the applicant. Mr. Asevedo, Mr. Palazzolo and Ms. Charara offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated January 11, 2013, and approve the request, as set forth in the Licensing Appeal Order, to transfer ownership of escrowed 2012 Class C license from Florkey's Lounge, Inc., transfer location of business, request new Specially Designated Merchant license and Dance Permit. Commissioner Olshove supported, and the motion was carried by unanimous vote.

5. Graham Market, Inc., 15801 Plymouth, Detroit, Wayne County
Request ID# 668031

The licensing hearing was conducted for Graham Market, Inc., Request ID# 668031. Rosendo Asevedo appeared on behalf of the Attorney Generals Office, Attorney Peter Abbo and Ziad Arabo, stockholder, appeared on behalf of the applicant. Mr. Asevedo and Mr. Abbo offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to affirm the previous Commission Order of denial dated December 19, 2012, and deny the request as set forth in the Licensing Appeal Order, to transfer ownership of 2012 Specially Designated Distributor and Specially Designated Merchant licenses from Kallo Investment, Inc. Commissioner Quimby supported, and the motion was carried by unanimous vote.

With no further business, moved by Commissioner Olshove, supported by Commissioner Quimby, that the Appeal Hearings be adjourned at 11:25 a.m., motion carried by unanimous vote.
