Chairman Deloney called the hearings to order at 10:06 a.m., noting a quorum was present.

1. Moved by Commissioner Olshove, supported by Chairman Deloney, that the minutes of the Southfield Appeal Hearing of March 7, 2013, be approved as written and presented, motion carried by unanimous vote.
2. Canton Petroleum, L.L.C., D/B/A Canton Petroleum, 41479 Michigan, Canton, Wayne County Business ID# 155297

The penalty hearing was conducted for Canton Petroleum, L.L.C., Business ID# 155297. Rosendo Asevedo appeared on behalf of the Attorney Generals Office, Attorney Frank Palazzolo, Bharat N. Bhatt and Jayshree Shah, members, appeared on behalf of the licensee. Mr. Asevedo, Mr. Palazzolo, Mr. Bhatt and Ms. Shah offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to suspend the license for 10 continuous days, as set forth in the Penalty Hearing Order, with the suspension being served from March 19, 2013 through March 28, 2013. Commissioner Olshove supported, and the motion was carried by unanimous vote.

6. Re-Fund, L.L.C., 31 N. Saginaw, Pontiac, Oakland County Request ID# 669487

Rosendo Asevedo appeared on behalf of the Attorney Generals Office and Robert Waun, Jr., sole member, appeared on behalf of the applicant. Mr. Asevedo and Mr. Waun offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated January 16, 2013 and approve the request as set forth in the Licensing Appeal Order, for a new Specially Designated Merchant license with Beer and Wine Sampling Permit. Commissioner Olshove supported, and the motion was carried by unanimous vote.

With no further business, moved by Commissioner Olshove, supported by Chairman Deloney that the Appeal Hearings be adjourned at 12:17 p.m., motion carried by unanimous vote.
