Chairman Deloney called the hearings to order at 10:05 a.m., noting a quorum was present.

1. Moved by Commissioner Olshove, supported by Commissioner Quimby, that the minutes of the Southfield Appeal Hearings held on April 11, 2013, be approved as written and presented, motion carried by unanimous vote.
2. The hearing for RD RC Incorporated, Request ID# 676838, scheduled for today, has been postponed.
3. Irene M. Perez, 2367 S. Michigan, Saginaw, Saginaw County Request ID# 664680

The licensing hearing was conducted for Irene M. Perez, Request ID# 664680. Rosendo Asevedo appeared on behalf of the Attorney Generals Office, Attorney Michael Jablonski and Irene M. Perez, stockholder, appeared on behalf of the applicant. Mr. Asevedo, Mr. Jablonski and Ms. Perez offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated January 16, 2013 and approve the request as set forth in the Licensing Appeal Order, for a new Specially Designated Merchant license. Commissioner Quimby supported, and the motion was carried by unanimous vote.

4. Trio's Entertainment, LLC, 11850 Livernois, Detroit, Wayne County Request ID# 565693

The licensing hearing was conducted for Trios Entertainment, LLC, Request ID# 565693. Rosendo Asevedo appeared on behalf of the Attorney Generals Office, Attorney David Draper and Sherman Givhan, sole member, appeared on behalf of the applicant. Mr. Asevedo, Mr. Draper and Mr. Givhan offered comments

regarding this case. After discussion on the record, Chairman Deloney made a motion to affirm the previous Commission Order of denial dated March 1, 2013 and deny the request as set forth in the Licensing Appeal Order, to transfer ownership of escrowed 2012 Class C and Specially Designated Merchant licenses with Sunday Sales Permit (P.M.) and Dance Permit from Trio's Entertainment, Inc. Commissioner Olshove supported, and the motion was carried by unanimous vote.

Mr. Asevedo offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to affirm the previous Commission Order of denial dated January 9, 2013 and deny the request as set forth in the Licensing Appeal Order, to transfer ownership of 2012 Specially Designated Merchant license from Shreeji N.K., Inc. Commissioner Quimby supported, and the motion was carried by unanimous vote.
