The violation hearing was conducted for CM II, L.L.C. d/b/a The Village Market, Complaint Nos. # 3-156423, 3-156446, 3-156447, 3-156448, 3-156457, 3-156515, 3-156576. Linda Pytel-McDowell appeared on behalf of the Attorney Generals Office and Attorney Seth P. Tompkins faxed a withdrawal of appeal on behalf of the licensee. Ms. Pytel-McDowell and Chairman Deloney offered comments for the record.

The licensing hearing was conducted for Holly Food, Inc., Request ID# 670891. Linda Pytel-McDowell appeared on behalf of the Attorney Generals Office, Attorney Peter Ewasek, and Raymond Antoon, General Manager/Owner, appeared on behalf of the applicant. Ms. Pytel-McDowell and Mr. Ewasek offered comments regarding this case. After discussion on the record, Chairman Deloney advised the matter would be tabled for a hearing on a future date.

5. Double J Co., L.L.C., d/b/a The Woodbridge Pub, 5169 Trumbull, Detroit, Wayne County

The licensing hearing was conducted for Double J Co., L.L.C., Request ID# 698479. Linda Pytel-McDowell appeared on behalf of the Attorney Generals Office, Attorney Kelly Allen and James Geary, sole member, appeared on behalf of the licensee. Ms. Pytel-McDowell, Ms. Allen and Mr. Geary offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated May 22, 2013, and approve the request, as set forth in the Licensing Appeal Order, for a new authorization for the outdoor sale, service and consumption of alcoholic liquor in a second area, to be held in conjunction with 2013 Class C license with Sunday Sales Permit (P.M.), Sunday Sales Permit (A.M.), Specific Purpose Permit(Food), Outdoor Service (1 Area) and 2 Bars. Commissioner Olshove supported, and the motion was carried by unanimous vote.

After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated May 22, 2013, and approve the request, as set forth in the Licensing Appeal Order, to transfer ownership of escrowed 2013 Class C and Specially Designated Merchant licenses with Sunday Sales Permit (P.M.) from BHK, L.L.C. and cancel existing Specially Designated Merchant license. Commissioner Quimby supported, and the motion was carried by unanimous vote.

With no further business, moved by Commissioner Olshove, supported by Commissioner Quimby, that the Appeal Hearings be adjourned at 11:23 a.m., motion carried by unanimous vote
