Commissioner Weatherspoon advised with the different styles of packaging being approved, the Commission needs to be in contact with the Michigan State Police as they need to be aware and have some training for the innovative styles of packaging that are out there for purchase. Commissioners Quimby commented that not only law enforcement agencies should be made aware of the new styles of packaging but also the retail licensees purchasing and selling the products.

IV. Chairman Deloney advised that a statutory change last year gave the Commission the ability to approve a program for marketing spirits in special or promotional packaging with nonalcoholic carbonated beverages and asked Ms. Wendt to expand on this inquiry. Ms. Wendt stated that several Vendors of Spirits have requested that the Commission approve promotional packaging that includes nonalcoholic carbonated beverages. She stated that there has been a meeting with representatives from the Michigan Department of Treasury, the Commission staff, and other interested parties regarding the promotional packaging and the 10 cent deposit required on nonalcoholic carbonated beverages to be included in the value added spirit packages. Ms. Wendt

advised that a draft order has been prepared which has been reviewed by the Assistant Attorneys General that approves the program for marketing spirits in special or promotional packaging with nonalcoholic carbonated beverages under specific conditions. Mr. Geissler agreed with Ms. Wendt and stated the order is ready for signing. Chairman Deloney summarized the six points included in the proposed order.

After a brief discussion, it was moved by Commissioner Quimby, supported by Commissioner Weatherspoon, and unanimously carried, that the administrative order be approved as written and presented.

V. Old Business

There was no old business.

VI. New Business

Ms. Wendt advised a new bill, SB 594 was introduced on September 7, 2011 by Senators Walker, Booher, and Proos which amends Section 603 of the Liquor Control Code and includes a new subsection (15) that permits a small wine maker to have a leasehold interest in a retailer. Ms. Wendt further indicated that another new bill, HB 4926 was introduced by Representatives Pscholka, Tyler, and Nesbitt on September 8, 2011 which amends Section 513 of the Liquor Control Code and includes a new subsection (4) that allows the Commission to issue a license to a private entity that leases an outdoor stadium on land owned by Lake Michigan College.

VII. Public Comments

Joe Cekola, President of CKL Corporation advised he filed an application last year to become an Authorized Distribution Agent (ADA) and inquired as to the status of that application. He advised they have been approached by some of their suppliers to become an ADA for spirit products not yet approved for sale in Michigan. Chairman Deloney explained the Office of Regulatory Reinvention (ORR) has created an advisory committee to conduct a comprehensive and thorough review of the rules and regulations of the Liquor Control Commission to determine if any changes should be considered. He advised that no subject is off the table from the licensing process, 3 tier system, why Michigan is a control state and what the distribution system of alcoholic beverages should look like in Michigan. Chairman Deloney stated the committee has a time table of four months to complete a report of recommendations. He advised the application for CKL Corporation will not be acted on until after the Liquor Control Advisory Rules Committee has completed its review because we do not know what the distribution system of alcoholic beverages will look like.
