- IV.** Mr. Robinson presented a summary of the August 2011 financial statement. Mr. Robinson reported this statement shows the results of our operations for the period of October 1, 2010 through August 31, 2011, and is comparable with the prior year in terms of the number of weeks for the year to date. He advised that Distilled Spirit cases sold have increased 178,014 (2.85%) during the first eleven months of the 2010-11 fiscal year and that Total Gross Sales have also increased by \$28.8 million (3.4%). Mr. Robinson advised Beer Taxes are lower than last year by \$670,000 and Wine Taxes are \$295,000 lower than last year. Mr. Robinson advised the Net Income from spirit sales is \$5.6 million higher than it was through eleven months last year (3.9%). He reported the total expenses are slightly higher in the current year, with most of the increase due to higher total distribution costs (higher number of cases).

- V.** Old Business

Ms. Wendt advised that Senate Bill 331 which eliminates the 1.85% specific tax on the retail selling price for spirits for off premises consumption was ordered enrolled on September 21, 2011. Ms. Wendt stated that the enrolled bill has an effective date of October 1, 2012.

There was no new business.

- VII.** Public Comments

There were no public comments.

Chairman Deloney commented that under the new permit policy, the Commission approved 19 items on the consent agenda during the morning Administrative Meeting today. He stated staff has been a great help creating a checklist and procedures to revamp this policy. Chairman Deloney advised he is keeping his promise to have the Commission speed up the licensing process, without compromising the public health, welfare and safety standards.
