On August 21, 2015, the Bureau Community and Health Systems issued a *Notice of Intent To Revoke* the child care center license of Grand Akidemy Development Center Inc.. In settlement of all issues raised in the *Notice of Intent To Revoke*, the undersigned parties hereby agree:

- 1) Licensee Designee Kathleen Wind and Grand Akidemy Development Center Inc, do not contest the allegations set forth in the *Notice of Intent* and agree that the Bureau may treat the allegations of fact and law as true, which findings shall have the same force and effect for purposes of this *Settlement Agreement* as if evidence and argument were presented in support of the allegations.
- 2) Licensee Designee Kathleen Wind and Grand Akidemy Development Center Inc. understand and intend that by so stating they are not admitting the truth of the allegations but agreeing that the Bureau may treat the allegations as true for purposes of resolution of the *Notice of Intent* and any future administrative or disciplinary matters concerning the above-referenced license.
- 3) Licensee Designee Kathleen Wind and Grand Akidemy Development Center Inc. understand that the child care center license will be revoked, effective November 25, 2015.
- 4) Licensee Designee Kathleen Wind and Grand Akidemy Development Center Inc. understand that it is unlawful to provide child care without a license. Licensee Designee Kathleen Wind and Grand Akidemy Development Center Inc., agree to cease providing child care at the licensed center location, or at any other unlicensed location upon the effective date of this agreement.

- 5) Licensee Designee Kathleen Wind and Grand Akidemy Development Center Inc. understand that they are waiving their right to an administrative hearing in the matter.
- 6) Licensee Designee Kathleen Wind and Grand Akidemy Development Center Inc. agree not to apply for a license or certificate of registration for a child care organization licensed or registered under the Child Care Organizations Act for a period of two years.
- 7) This agreement does not prohibit Licensee Designee Kathleen Wind from having a connection with a licensed child care home or center so long as the home or center is not at her place of residence, and she is not employed at the home or center in a position of registrant, licensee, licensee designee, program director, administrator, lead caregiver, or caregiver.
