
SETTLEMENT AGREEMENT

On July 9, 2015, the Bureau of Community and Health Systems issued a *Notice of Intent to Refuse To Renew* the family child care home certificate of registration of Debra Sovo.


In settlement of all issues raised in the *Notice of Intent to Refuse To Renew*, the undersigned parties hereby agree:

- 1) Debra Sovo admits to the violations cited in the Notice and no longer wishes to contest the refusal to renew of her child care family home certificate of registration.
- 2) Debra Sovo understands that her family child care home certificate of registration will be not be renewed, effective October 24, 2015. Ms. Sovo agrees to cease providing care to unrelated children in her home on or before October 24, 2015.
- 3) Debra Sovo understands that under MCL 722.125, Section 15(1), a person who provides child care without a license or certificate of registration is guilty of a misdemeanor, and the offense is punishable by up to 90 days imprisonment and/or a \$1,000 fine.
- 4) Debra Sovo understands that she is withdrawing her appeal of the *Notice of Intent to Refuse To Renew* her certificate of registration, and an administrative hearing will not be held in this matter.
- 5) Debra Sovo agrees not to apply for a license or certificate of registration for a Child Care Organization licensed or registered under the Child Care Organizations Act for a period of two years, and agrees not to be connected, directly or indirectly, with a licensee or registrant for a period of two years from October 24, 2015.
