Dear Ms. Green:

On June 16, 2015, the Bureau of Health Care Services, now known as the Bureau of Community and Health Systems, forwarded to you Special Investigation Report #2015D0428016, completed by Licensing Consultant Kathryn Curreathers. Ms. Curreathers found you to be in noncompliance with licensing rules R 400.1902(2), R 400.1908(2) and R 400.1910(2). Specifically, you failed to maintain appropriate attendance records from June 6, 2010, through February 8, 2014, resulting in the Office of Inspector General determining that you had fraudulently billed the Department of Human Services in the amount of \$134,553.68. Additionally, you exceeded your licensed capacity on May 4<sup>th</sup>, 5<sup>th</sup>, 7<sup>th</sup>, 13<sup>th</sup>, 14<sup>th</sup> and 15<sup>th</sup> of 2015 and you were out of ratio on May 15, 2015.

As a result, the Bureau of Community and Health Systems is allowing you the opportunity to administratively close your group child care home license. If, within 30 days of receipt of this certified letter, you wish to object to the administrative closure you may do so, in writing, to the address listed below. Upon receipt of your written objection, the Bureau of Community and Health Systems will proceed with a formal notice of intent to recommend revocation of your group child care home license.
