**LICENSING APPEAL ORDER**

On May 9, 2012, Greenfield Super Market, Inc. (applicant) filed a request to transfer all of the stock interest in a 2012 SDM license with Sunday Sales Permit (A.M.) at the above noted location, by adding Jeffrey Farida, Ricky Farida, Tony Farida and Eric Farida as new stockholders with 21,255.04 shares of stock each, through a transfer of a total of 87,100.16 shares of stock from existing stockholder, Hamid Farida.

At a meeting held on December 27, 2012, the Commission denied this request under administrative rule R 436.1105(2)(a) after considering the extensive operating record of Tony Farida as a former licensee of the Commission at multiple locations. Tony Farida plans to devote full time to the operation of the business at this location. The Commission also based the denial of this application under administrative rule R 436.1105(2)(g) after considering the conviction history of Tony Farida involving the possession with intent to deliver controlled substances.

Attorney Joseph Shallal submitted a timely request for an appeal in this matter and represented the applicant at the January 31, 2013 hearing, held at the Commission's Southfield office.

After hearing arguments, reviewing the MLCC file, and discussion of the issue on the record, the Commission finds sufficient reasons to reverse its denial issued in this matter and remand the application to the Commission's Licensing Division for further processing to allow the applicant to amend this application for the reasons stated on the record.

Under Article IV, Section 40, of the Constitution of Michigan (1963), the Commission shall exercise complete control of the alcoholic beverage traffic within this state, including the retail sales thereof, subject to statutory limitations. Further, the Commission shall have the sole right, power, and duty to control the alcoholic beverage traffic and traffic in other alcoholic liquor within this state, including the manufacture, importation, possession, transportation and sale thereof under MCL 436.1201(2).

THEREFORE, IT IS ORDERED that the denial order of December 27, 2012 issued in this matter is REVERSED and the matter is REMANDED to the Commission's Licensing Division for further processing.
