LICENSING APPEAL ORDER

On September 30, 2014, Kara Coraci (applicant) filed a request for a new Salesperson license.

At a meeting held on October 8, 2014, the Commission denied this request under administrative rules R 436.1105(2)(g)(ii), R 436.1105(2)(g)(h), and R 436.1105(2)(j) after considering the prior arrest and conviction record of the applicant; and the effects that issuance of a license would have on the health, welfare, and safety of the general public when determining whether an applicant should be issued a license or permit. The Commission also denied this request under MCL 436.2003 because the applicant failed to disclose her arrest and conviction record on the application form.

Kara Coraci submitted a timely request for an appeal in this matter and represented herself at the January 13, 2015 hearing, held at the Commission's Lansing office.

After hearing arguments, reviewing the MLCC file, and discussion of the issue on the record, the Commission finds that the applicant sufficiently provided mitigating circumstances relative to her past conviction record and disclosure of same during the application process; removing the previous questions concerning the applicant.

Under Article IV, Section 40, of the Constitution of Michigan (1963), the Commission shall exercise complete control of the alcoholic beverage traffic within this state, including the retail sales thereof, subject to statutory limitations. Further, the Commission shall have the sole right, power, and duty to control the alcoholic beverage traffic and traffic in other alcoholic liquor within this state, including the manufacture, importation, possession, transportation and sale thereof under MCL 436.1201(2).

The Commission finds sufficient reasons to reverse its denial issued in this matter and to approve the applicant's request for the reasons stated on the record.

THEREFORE, IT IS ORDERED that:

A. The denial order of October 8, 2014 issued in this matter is reversed and the applicant's request for a new Salesperson license is APPROVED.

B. Under administrative rule R 436.1003, the licensee shall comply with all state and local building, plumbing, zoning, sanitation, and health laws, rules, and ordinances as determined by the state and local law enforcements officials who have jurisdiction over the licensee. Approval of this license by the Michigan Liquor Control Commission does not waive any of these requirements. The licensee must obtain all other required state and local licenses, permits, and approvals before serving or selling alcoholic liquor.

C. Failure to comply with all requirements of licensure in the State of Michigan will result in the licensee being charged with a violation of the Michigan Liquor Control Code, Administrative Rules, and Commission order, which may result in fines, suspension, and/or revocation of this license.
